Introduction

CCS Mission:

Cherokee Central Schools is committed to empowering our students, preserving our nation, and ensuring our future.

CCS Vision:

The Cherokee Central Schools System will be a community where each student will graduate from high school, will be globally competitive for work and postsecondary education, will possess an appreciation for and an eagerness to preserve our nation, and will be prepared for life in the 21st century.

Cherokee Central Schools (CCS) became a tribally operated school district in 1990, under a PL 100-297 grant from the Bureau of Indian Affairs Department of Education. The Eastern Band of Cherokee Indians (EBCI) Tribal Council passed a resolution at that time authorizing the CCS School Board to operate the schools as a policy-making entity.

Cherokee Central Schools is governed by a six-member, elected school board, along with a nonvoting representative from EBCI Tribal Council. Each member serves a four-year term. Leadership roles at the central office consist of the superintendent, assistant superintendent, and nine directors/coordinators. These administrators facilitate programs in special education, testing, curriculum, professional development, culture, human resources, finances, facilities, ESTEAM education¹, and information technology.

A principal leads each of the three schools – Cherokee Elementary, Cherokee Middle, and Cherokee High School. Cherokee High School and Cherokee Middle School have an assistant principal, and Cherokee Elementary School has two assistant principals.

In August 2009, the elementary, middle, and high schools relocated to a brand new, state-ofthe-art campus. This move came about because of the hard work and determination of the tribe to regain the Ravensford Tract from the Great Smoky Mountains National Park (GSMNP) for the purposes of reclaiming what was once a tribal settlement, reconnecting two separate parts of the Boundary, and creating an educational nucleus for our people. The campus houses all three

schools, central office, facilities maintenance, Hope Center, Information Technology (IT), and alternative learning programs.

When opened in 2009, the campus was the largest green building project in the region, achieving Silver LEED certification. Ninety percent of the waste generated from the construction project has been recycled, and it is projected to use 35% less energy than a conventionally built project. The campus boasts of daylighting in over 75% of its space, and CCS also harvests rainwater.

The campus includes computer labs, science labs, cultural centers (including the 350 seat Gathering Place), alternative learning centers, a 1040-seat performing arts center, sports arena, stadium, stickball field, and boys' and girls' fitness centers.

The school calendar provides 185 instructional days for students, and it includes teacher workdays and professional development days. Most courses in the elementary and middle schools are taught as year-long courses. Most courses in the high school are taught on a block schedule.

Cherokee Central Schools' school board policy requires that each school implement North Carolina's Standard Course of Study. Because much of the funding for the district is funneled through the Bureau of Indian Education (BIE), Cherokee Central Schools must follow additional BIE requirements, including adhering to North Carolina's Accountability Workbook to meet federal requirements. Successful completion of the Cherokee Language and History course is a local graduation requirement, as is completing a CPR course.

The Youth Risk and Resiliency Survey (YRRS) is a validated survey for youth based on the Youth Risk Behavior Surveillance System (YRBSS), a large, voluntary biennial national survey that obtains data from high school students themselves on a variety of health risk behaviors. The YRBSS was developed by the Centers for Disease Control and Prevention (CDC) in 1990 and has since collected data from more than 3.8 million high school students from state, territorial, tribal government, and local school-based surveys across the nation.² The YRBSS was administered approximately every three years at CCS middle and high schools, beginning in 1994 through 2009. The data collected during this period was owned by the BIE rather than the school itself.

In March and April 2016, Cherokee Central Schools, Western Carolina University, and the EBCI Public Health and Human Services Division, collaborated to administer the YRRS questionnaire to CCS Middle and High School students.³ CCS chose to conduct the YRRS instead of the YRBSS

because New Mexico partners added and validated questions about resiliency to create the YRRS for middle and high school students. Resiliency is an important indicator of health and wellness among Al/AN communities due to historical trauma, adverse childhood experiences, isolated geographical locations, and under-representation in national priorities. Questions specific to Eastern Band of Cherokee culture were not included in the YRRS because the resiliency questions were already validated, that is, proven to be dependable and able to give clear and useful results when answered. Adding questions would have required an additional validation process. In addition, New Mexico's population includes approximately 10-11% American Indian/ Alaska Natives (AI/AN), so CCS and PHHS considered the survey particularly applicable to EBCI.⁴

The YRRS designed for high school students was also administered to the CCS Middle School students. The high school survey includes additional risk questions that CCS wanted to assess among middle schoolers. All responses were self-reported by the students and a total of four-hundred and twenty-four (n=424) surveys were complete enough for analysis. Eighty-two percent of the CCS Middle and High School student population completed the survey and approximately 87% of the respondents identified their race as American Indian/Alaska Native (AI/AN).

When CCS completed the YRRS in 2016, it was the first time the school was asked to conduct a survey in which the data would be owned by the school. This valuable information on youth behaviors empowers the school and Tribal partners to tailor interventions and resources necessary to meet their needs more effectively.

In 2018, the school conducted the survey for the second time. CCS will conduct this survey every two years to track data and develop interventions accordingly.

The YRRS results will be shared in various formats for different audiences. Some of this youth data will be included in the 2018 EBCI Tribal Health Assessment process and product. Methodology

Survey Instrument

The Youth Risk and Resiliency Survey (YRRS) is a validated survey for youth based on the CDC's Youth Risk Behavior Survey (YRBS), a large, voluntary biennial national survey that obtains self-reported data from high school students on a variety of health issues. New Mexico partners added and validated questions about resiliency to create the YRRS for middle and high school students. In April and May 2018, Cherokee Central Schools and PHHS collaborated to administer the YRRS questionnaire to CCS middle and high school students.

The YRRS is online available at <u>http://www.youthrisk.org</u>; paper copies can be requested by contacting CCS or PHHS. New Mexico partners in YRRS are NM Public Education Department, NM Department of Health, and University of NM School of Medicine Prevention Research Center. The YRRS is given every two years across New Mexico, whose population includes 10-11% AI/AN.

Sample Approach and Design

The YRRS was administered during spring 2018, over the course of 4 weeks. The survey was administered by grade level (e.g., all grade 6 students completed the survey at the same time) to students in regular core academic courses who were present in the computer lab to complete a benchmark assessment. Make-up times for absent or non-participating students were not provided. Students were provided a link on computers to access the instrument. Teachers proctored the sessions and facilitated the administration of the YRRS by reading a brief introductory script explaining the survey and assuring anonymity (see Appendix B). Each student was provided with contact information for behavioral health services, the Cherokee Indian Hospital, and school counselors in case they wanted to discuss anything further after survey completion (see Appendix C).

Population and Sample Characteristics

According to a student enrollment report dated May 29, 2018, there were 587 students enrolled in Cherokee Central Schools, grades 6 through 12.⁵ Approximately 64% of the enrolled students (376 out of 587) participated in the YRRS.

Approximately 89% of the respondents identified their race as American Indian/Alaska Native (Al/AN) (either alone or in combination with another race). The responses presented in this report represent only those students who participated in the survey.

The following table highlights the demographic characteristics of the sample compared to the total CCS student body in middle school and high school.

Limitations

Please keep in mind the following limitations when viewing the survey findings:

• The New Mexico YRRS was originally designed as two separate surveys for middle school and high school students. The decision was made to use the High School version for both CCS middle school and high school students. It is possible that some questions may have been misinterpreted or misunderstood by the younger audience.

- It is not possible to know the extent of over-reporting (where students said they engaged in a behavior *more* than they truly did) or underreporting (where students reported engaging in a behavior *less* than they actually did) for some questions.
- As shown in the table above, the demographic breakdown of students at CCS does not match the demographic breakdown of students who participated in the survey. Notably, while each grade makes up approximately 12 to 17 percent of students at CCS, the percentage of 17 and 18+ year olds responding to the survey was significantly less than that, at 9.04% and 5.48% respectively. Because of this, the results cannot be generalized to the CCS population.
- The survey data displayed is only representative of students who participated in the survey, which does not include youth not enrolled in school or Cherokee students enrolled in other school systems including Swain County Schools, Jackson County Schools (Smoky Mountain), Graham County Schools (Robbinsville), and Cherokee County Schools. Even among students, there may have been differences between those who responded to the survey and those who did not.

Data Notes

Each section begins with a graph comparing the responses of middle school and high school students. The information in that section is then broken down by question. The question is listed, as well as the possible answer choices for that question. For each question, data is presented for high school and middle school totals and broken down by sex and American Indian or Alaska Native Race. Any special considerations for the data, such as questions where some of the population was excluded, are listed below each graph. Below this, the data is described.

- When possible, national level data was included for comparisons. National aggregate data for middle school students was not available from the CDC at the time of this publication. National aggregate data for high school students was retrieved from the 2017 Youth Risk and Behavioral Survey. This information is available at: https://nccd.cdc.gov/Youthonline/
- National level data is presented in gold, local high school data is presented in green, and local middle school data is presented in blue.
- Throughout this report, the abbreviation MS indicates Middle School and HS indicates High School.
- AI/AN indicates American Indian or Alaska Native; this category includes students who marked AI/AN for *at least one* of their races.

• In cases where confidentiality to could not be maintained, information has been excluded from the presented data.

Comparisons to the 2016 CCS YRRS

Individuals working with the YRRS are urged to use caution when comparing the 2018 data presented here with data from 2016 YRRS. Comparisons between the two data sets are likely to be unreliable and may present a false picture of change in the population. There are three reasons for this:


- The first is that the sample population from 2018 (the individuals who took the survey) differs significantly in size and makeup from the sample population in 2016. In 2016, the response rate was 82% of the student population; in 2018, the response rate was 64% of the population. Both rates are valid, but the discrepancy in coverage may explain differences between the surveys.
- Second, some questions have been changed between 2016 and 2018. When particularly salient, the change has been noted within the document. For more information on indicator definitions, see Appendix A.
- Third, the data only represents a snapshot in time. External factors, such as flooding, deaths in the community, or political climate can affect the ways that students answer these questions. To determine if change is a trend or just a change, we need 3 data points. The 2020 YRRS will be able to show these trends and will make comparisons in the data.

Comparisons between the data are not necessarily invalid, but individuals wishing to make these comparison are encouraged to give greater scrutiny to the results than they might otherwise do.

Survey Findings

Personal Safety

The 2018 questionnaire asked six questions related to the topic of personal safety. The figure below compares the responses of middle schoolers to the responses of high schoolers.




- Approximately half of middle schoolers and high schoolers reported that a gun in their home.
- Compared to middle school respondents, higher proportions of high schoolers reported riding with someone who had been drinking alcohol and driving after drinking alcohol.
- Approximately one-third of high schoolers reported texting or emailing while driving, less than the national average of 41.5%.
- High schoolers and middle schoolers were equally likely to wear a seatbelt.
- High schoolers were more likely than middle schoolers to "never or rarely" wear a bicycle helmet.

Bicycle Helmet

When you rode a bicycle during the past 12 months, how often did you wear a helmet?

(Answer choices: I did not ride a bicycle during the past 12 months, never, rarely, sometimes, most of the time, always).




• Students who answered, "I did not ride a bicycle during the past 12 months" were excluded from these results.

• Data is based on 155 middle school students and 97 high school students who had ridden a bicycle in the past 12 months.

- A large majority of middle school and high school students "never" or "rarely" wear a bicycle helmet when riding a bicycle.
- High school students were more likely to "never" or "rarely" wear a helmet (89%) compared to middle school students (79%) in the past year.
- Among middle school students, females were slightly less likely to "never" or "rarely" wear a helmet when riding a bicycle compared to males.
- Among high school respondents, the percentage of students reporting "never" or "rarely" wearing a helmet were similar across all four groups presented.

Seatbelt Use


How often did you wear a seatbelt when riding in a car driven by someone else? (Answer choices: never, rarely, sometimes, most of the time, always)



- 9% of high school students and 9% of middle school students "never" or "rarely" wear a seatbelt when riding in a car driven by someone else.
- Among respondents, males were more likely than other groups to report "never" or "rarely" wearing a seatbelt when riding in a car driven by someone else.

Rode in a Car/Vehicle with Driver Who Had Been Drinking Alcohol


During the past 30 days, how many times did you ride in a car or other vehicle driven by someone who had been drinking alcohol? (Answer choices: 0 times, 1 time, 2 or 3 times, 4 or 5 times, 6 or more times)



 Compared to middle schoolers (14%), a higher proportion of high schoolers (23%) reported riding in a car/vehicle with someone who had been drinking alcohol one or more times in the past 30 days.

Drove After Drinking Alcohol

During the past 30 days, how many times did you drive a car or other vehicle when you had been drinking alcohol? (Answer choices: I did not drive a car or other vehicle during the past 30 days, 0 times, 1 time, 2 or 3 times, 4 or 5 times, 6 or more times)




 Data is based on 94 middle school students and 101 high school students who selected an answer other than "I did not drive a car during the past 30 days"

- While almost all middle school respondents were not of legal driving age, only 53% (n=106) of them responded that "I did not drive a car or other vehicle in the past 30 days."
- Compared to middle school students (4%), a higher proportion of high school respondents (10%) reported driving a car/vehicle after drinking alcohol one or more times in the past 30 days.
- 12% of high school males reported driving after drinking alcohol.

Texting and Driving


During the past 30 days, on how many days did you text or e-mail while driving a car or other vehicle? (Answer choices: I did not drive a car or other vehicle, 0 days, 1 or 2 days, 3 to 5 days, 6 to 9 days, 10 to 19 days, All 30 days).



 Data is based on 86 middle school students and 103 high school students who selected an answer other than "I did not drive a car during the past 30 days"

- One third of high school drivers (33%) reported texting or emailing while driving.
- Among high school students, a higher proportion of males (40%) reported texting or emailing while driving one or more days in the past 30 days compared to females (24%).

Gun in the Home




Is there a gun in your home? (Answer choices: Yes, No, Not sure)

- Around half of both middle school (47%) and high school participants (50%) reported that there was a gun in their home.
- A higher proportion of males (52%) reported a gun in their home compared to other groups.

Violence


The 2018 questionnaire asked eleven questions related to the topic of violence and violencerelated behaviors. Three of those questions related specifically to intimate partner violence and two of them related to bullying; those questions will be discussed separately. The figure below compares the responses of CCS middle schoolers, CCS high schoolers, and national high schoolers on a subset of the violence-related questions.



- Compared to middle school students, a higher percentage of high school students reported carrying a weapon, carrying a gun, carrying a weapon on school property and skipping school due to safety concerns.
- Compared to high schoolers, a higher percentage of middle schoolers reported getting in a physical fight and getting in a physical fight on school property.
- CCS Students were 3 times as likely to skip school due to safety concerns as high schoolers nationally.

Carried a Weapon


During the past 30 days, on how many days did you carry a weapon such as a gun, knife, or club? (Answer choices: 0 days, 1 day, 2 or 3 days, 4 or 5 days, 6 or more days)



- A higher proportion of high school students (29%) reported carrying a weapon on one or more days in the past 30 days, compared to middle school respondents (17%).
- Among middle schoolers, a higher percentage of males (29%) reported carrying a weapon on 1 or more days in the past 30.
- Similarly, a higher proportion of high school males (42%) reported carrying a weapon compared to other high school groups.

Carried a Gun


During the past 30 days, on how many days did you carry a gun? (Answer choices: 0 days, 1 day, 2 or 3 days, 4 or 5 days, 6 or more days)



- A higher proportion of high school students (9%) reported carrying a gun on one or more days in the past 30 days compared to middle school students (6%).
- Males, in both middle school and high school, are most likely to carry a gun (8% of middle school males and 15% of high school males) compared to other groups.

Carried a Weapon on School Property


During the past 30 days, on how many days did you carry a weapon such as a gun, knife, or club on school property? (Answer choices: 0 days, 1 day, 2 or 3 days, 4 or 5 days, 6 or more days)



- 10.1% of high schoolers reported carrying a weapon on school property on one or more days in the past 30 days, similar to the responses among high school AI/AN students (9.6%).
- There were not enough responses from middle school students to maintain confidentiality; therefore, that data is not presented here.

Skipped School Due to Feeling Unsafe


During the past 30 days, on how many days did you not go to school because you felt you would be unsafe at school or on your way to or from school? (Answer choices: 0 days, 1 day, 2 or 3 days, 4 or 5 days, 6 or more days)



- 21% of high schoolers and 19% of middle schoolers reported skipping school due to safety concerns on 1 or more days in the last 30 days.
- High school females and high school males were similarly likely to skip school due to safety concerns; middle school females were much more likely (27%) to skip school due to safety concerns than middle school males (10%).


In a Physical Fight

During the past 12 months, how many times were you in a physical fight? (Answer choices: 0 days, 1 day, 2 or 3 days, 4 or 5 days, 6 or more days)



- Just over 1/4 of middle school students (26%) reported being in a physical fight in the past year; similarly, about 1/4 of all high school students (25%) had been in a physical fight.
- Among middle school respondents, a higher proportion of males (32%) had been in a physical fight at least once in the past 12 months compared to other groups, including females (20%).
- Among high school respondents, a higher proportion of males (30%) had been in a physical fight at least once in the past 12 months compared to other groups, including females (19%).

In a Physical Fight on School Property



During the past 12 months, how many times were you in a physical fight on school property? (Answer choices: 0 days, 1 day, 2 or 3 days, 4 or 5 days, 6 or more days)


- A higher proportion of middle school students (16%) reported being in a physical fight on school property one or more times in the past year compared to high school students (15%)
- 21% of middle school males reported being in a physical fight on school property at least once in the past year, the highest proportion among middle school groups.
- Among high school respondents, a higher proportion of males (18%) reported being in a physical fight on school property one or more times in the past 12 months compared to other groups.

Bullying

The 2018 Questionnaire asked two questions related to bullying. The two figures below display the responses to those questions.

During the past 12 months, have you ever been bullied on school property? (Answer


choices: Yes, No)



- 1/4 of high school students (25%) and 1/5 of middle school students (22%) reported being bullied on school property one or more times in the past 12 months.
- Among middle school students, females were slightly more likely to experience bullying on school property than males.
- Among high school students, a higher proportion of females (33%) reported being bullied on school property in the past year compared to males (20%).

Electronically Bullied



- Compared to the national average for high school students (20%), fewer CCS students reported being electronically bullied in the last 12 months (17% for HS, 12% for MS)
- A lower proportion of high school AI/AN students (13%) reported experiencing electronically bullying in the past year compared to all high school respondents (17%).
- 23% of high school females reported being electronically bullied in the past year, a higher proportion than other groups.

Intimate Partner Violence


The 2018 questionnaire asked three questions related to the topic of violence within dating relationships. The figure below displays the responses to those questions.



- 11% of high school participants reported being hit or injured by their dating partner.
- 8% of high school students reported being forced to have sex (rape or sexual assault) and 10% reported that they had experienced sexual dating violence.
- 6% of middle schoolers reported experiencing physical dating violence. 3% reported experiencing sexual dating violence; 3% reported having been forced to have sex.

Forced Sexual Intercourse


Have you ever been physically forced to have sexual intercourse when you did not want to? (Answer choices: Yes, No)








• *Of those who attempted suicide.

- Compared to middle school students, a higher proportion of high school students reported engaging in or experiencing mental health behaviors of concern.
- Among high school students, almost 1/3 felt sad or hopeless (31%), 1/5 engaged in nonsuicidal self-harm (20%), 12% seriously considered suicide, 15% made a suicide plan, and 14% attempted suicide.
- Among middle schoolers, 1/5 felt sad or hopeless (23%), 14% engaged in non-suicidal self-harm, 11% seriously considered suicide, 10% made a suicide plan, and 5% attempted suicide.
- While CCS high school students were less likely to seriously consider suicide than the national average, they were equally likely to make a suicide plan (14.6% Nationally vs 14.65% CCS HS), and more likely to attempt suicide (9% Nationally vs 14% CCS HS).

Non-Suicidal Self Harm



Felt Sad or Hopeless



Seriously Considered Suicide


During the past 12 months, did you ever seriously consider attempting suicide? (Answer choices: Yes, No)

Made Suicide Plan


During the past 12 months, did you make a plan about how you would attempt suicide? (Answer choices: Yes, No)




Tobacco Use

- High schoolers are more likely than middle schoolers to engage in various forms of tobacco use.
- Nearly half of all high schoolers (48%) and 1/4 of all middle schoolers (24%) have ever smoked cigarettes.
- 1/4 of high school students (24%) and 7% of middle school students are current cigarette smokers and more are electronic vapor users (38% of high schoolers and 15% of middle schoolers.)
- 43% of high school students and 39% of middle school students were exposed to second hand smoke in the last week.

Ever Tried Cigarettes




Have you ever tried cigarette smoking, even one or two puffs? (Answer choices: Yes, No)

Age of First Cigarette






















- Almost half of all high school students (47%) and 23% of middle school students have ever drank alcohol.





















- Males (9% of middle school males and 22% of high school males) were most likely to report that they had been offered, sold or given illegal drugs on school property.



- Among high school students, 47.3% reported that they have had sexual intercourse at least once, 32% were sexually active in the past 3 months, 19% reported having had at least four partners in their lifetime, and 8% reported that they first had sexual intercourse before they were 13 years old.
- 10% of middle schoolers and 12% of high schoolers identify as gay, lesbian, or bisexual.
- 73.2% of high school students and 69% of middle school students used at least 1 form of contraception.




Have you ever had sexual intercourse? (Answer choices: Yes, No)













- Among middle schoolers, males were more likely to report that either they or their partner used some method to prevent pregnancy.
- Condoms were the most commonly reported form of birth control for middle school and high school students, followed by "no method/not sure" for middle schoolers and long term/reliable birth control for high schoolers.
- The majority of high school students reported using some form of birth control, as did the majority of middle school students.
- Approximately ¹/₄ of the high school students, across all groups, who have had sexual intercourse were either unsure about the method used or reported using no method of birth control.
- Approximately 31% of high school students and 15% of middle school students reported using a reliable, long-term birth control method.

- 10% of middle school students and 12% of high school students identifies as gay, lesbian or bisexual.

- Among middle school students, a higher proportion of females (15%) identify as gay, lesbian, or bisexual compared to other groups.


Pregnancy

The 2018 questionnaire asked multiple questions about nutrition, some which were combined (as described below) to create four nutrition variables. The figure below compares the responses of middle schoolers to the responses of high schoolers.




- 37% of middle schoolers and high schoolers ate 3 or fewer servings of fruit and/or 100% fruit juice per week; 51% of middle school students and 53% of high school students ate 3 or fewer vegetable servings per week.
- About 40% of high school students and 38% of middle school students drank soda at least once a day.
- 18% of both middle school and high school students reported not eating breakfast in the previous week.

Fruits and Fruit Juice


• 37% of high school students and middle school students ate fruit and/or drank 100% fruit juice 3 times or less in the previous week.



- In 2018, EBCI removed two questions from the YRRS relating to nutrition and vegetables. These questions were about carrots and potatoes, which were previously included when calculating the total number of vegetables a student consumed in the last week. In the current formulation of the YRRS, a student would not have reported eating vegetables if those vegetables were carrots or potatoes. Because of this, the percentage of students who reported eating "3 or fewer servings of vegetables in the last week" increased significantly. In other words, this statistic is most likely inflated and is thus not valid. It is recommended that individuals using this statistic do so with a critical eye, noting the potential differences between the statistic as reported and the reality of vegetable consumption in EBCI.
- 51% of high school students and 53% of middle school students reported eating 3 or fewer servings of vegetables in the last week.

Sugared Beverages



- Among high school students, a higher proportion of males (42%) reported drinking at least one soda a day compared to less than 40% among other groups.

Breakfast



- About 18% of middle and high school students reported that they *never* ate breakfast in the past week.

Physical Activity


The 2018 questionnaire asked four questions about physical activity and screen time. The figure below compares the responses of middle schoolers to the responses of high schoolers.



- High school students reported behaviors associated with a sedentary lifestyle in greater proportions than middle school students.
- Most middle school and high school students were physically active for 60 minutes at least once in the last week; 11% of middle schoolers and 19% of high schoolers reported no physical activity (in the past week) of at least 60 minutes.
- 29% of middle school students and 27% of high school students watched 3 or more hours of TV daily.
- 47% of middle school students and over half of high school students (54%) used a computer for 3+ hours a day.
- Middle school students were much more likely to have a weekly PE class (only 30% reported that they did not go to a weekly PE class) than high school students (46% reported that they did not attend weekly PE).

Physical Activity

During the past 7 days, on how many days were you physically active for a total of at least 60 minutes per day? (Add up all the time you spent in any kind of physical activity that increased your heart rate and made you breathe hard some of the time.) 
- Middle School males were the most likely (39%) to have been physically active every day of the last week. High school females were the least likely (22%) have been physically active every day of the last week.
- Approximately 20% of high school students reported no physical activity in the last week, nearly double the percentage of middle school students (11%) reporting no physical activity.
- The majority of students reported being physically active at least 4 days a week.

Other Topics

The 2018 questionnaire asked fifteen questions related to various health related topics. These questions are presented below.

HIV Screening


Have you ever been tested for HIV, the virus that causes AIDS? (Do not count tests done if you donated blood.) (Answer choices: Yes, No, Not sure)



- A higher proportion of high school students (14%) had ever been tested for HIV compared to middle school students (6%).

- Similarly, for middle school students, a higher proportion of females (7%) reported having been tested compared to males (5%).

Last Dentist Visit



- More than half of the students in both middle school and high school reported a dentist visit in the past year; a higher proportion of middle school students (68%) reported being to the dentist in the past 12 months compared to high school students (61%).
- Females were most likely to visit the dentist. Among middle school students, a larger proportion of females (70%) reported a dental visit within the last 12 months compared to other groups. Among high school students, a larger proportion of females (69%) also reported a visit to the dentist within the last year compared to other groups.


Diagnosed with Asthma

- 40% of all high school students and 29% of all middle school students reported an asthma diagnosis.

Current Asthma




Do you still have asthma? (Answer choices: I have never had asthma, Yes, No, Not sure)

Sleep



School Grades

- 40% of high school students and 30% of middle school students received grades of mostly A's during the previous year.
- 5% of middle schoolers and high schoolers had received mostly D's and F's.
- Females are more likely to get A's and B's than males. 77% of middle school females received A's and B's compared to 62% of males. In high school, 82% of females received A's and B's compared to 70% of males.

Gambling



Disability


Do you have any physical disabilities or long-term health problems? (Long-term means 6months or more) (Answer choices: Yes, No, Not sure)

Housing



- 15% of middle and high school students speak a language other than English more than half the time at home.
- High school males are nearly twice as likely (20%) as high school females (11%) to primarily speak a language other than English at home.




- Almost all of the respondents in both middle school and high school were born in the USA.































- 47% of high school students and 39% of middle school students reported that they would use a clinic located on school property. Another 34% of high school students and 48% of middle school students indicated that they were unsure if they would use a school clinic or not.
- 20% of high school students and 13% of middle school students indicated that they would not use a school clinic.

Answered '1 or 2 times' or more to the question, *During the past 30 days, how many times have you sniffed glue, breathed the contents of aerosol spray cans, or inhaled any paints or sprays to get high?*

Current heroin use

Answered '1 or 2 times' or more to the question, *During the past 30 days, how many times have you used heroin (also called smack, junk, or China White)?*

Current methamphetamine use

Answered '1 or 2 times' or more to the question, *During the past 30 days, how many times have you used methamphetamines (also called speed, crystal, crank, or ice)?*

Current ecstasy use

Answered '1 or 2 times' or more to the question, *During the past 30 days, how many times have you used ecstasy?*

Current synthetic marijuana use

Answered '1 or 2 times' or more to the question, *During the past 30 days, how many times have you used synthetic marijuana (also called K2 or Spice)?*

Drugs on school property

Answered 'Yes' to the question, During the past 12 months, has anyone offered, sold, or given you an illegal drug on school property?

Sexual Activity

Ever had sexual intercourse

Answered 'Yes' to the question, *Have you ever had sexual intercourse*? Sexual intercourse before age 13

Answered '11 or 12 years old' or younger to the question, *How old were you when you had sexual intercourse for the first time?* AMONG those who are sexually active

Four or more sexual partners in lifetime

Answered '4 people' or more to the question, *During your life, with how many people have you had sexual intercourse?* AMONG sexually active students.

Recently sexually active

Respondent reported having sexual intercourse within the previous 3 months. Answered '1 person' or more to the question, *During the past 3 months, with how many people did you have sexual intercourse?* AMONG sexually active students.

Alcohol or drug use before sexual intercourse

Answered 'Yes' to the question, *Did you drink alcohol or use drugs before you had sexual intercourse the last time?* AMONG sexually active students.

Did not use condom

Answered 'No' to the question, *The last time you had sexual intercourse, did you or your partner use a condom?* AMONG those who reported being "Sexually active"

Identifies as gay, lesbian or bisexual

Answered 'Gay or lesbian' or 'Bisexual' to the question, *Which of the following best describes you?*

Pregnancy

Answered 'Yes' to the question, Have you ever been pregnant?

Nutrition

3 or fewer servings of fruit/100% fruit juice per week

Combined answers to the questions, During the past 7 days, how many times did you:

- Drink 100% fruit juices
- Eat fruit.

Answered 'I did not drink 100% fruit juices/ fruit' to both questions OR '1 to 3 times during the past 7 days' to ONE of the questions.

3 or fewer servings of vegetables per week

Combined answers to the questions, During the past 7 days, how many times did you:

- Eat green salad
- Eat other vegetables

Answered 'I did not eat (green salad/other vegetables)' to ALL questions OR '1 to 3 times during the past 7 days' to ONE of these four questions.

Drank soda/pop at least once every day

Answered '1 time per day', '2 times per day', '3 times per day', or '4 or more times per day' to the question, *During the past 7 days, how many times did you drink a can, bottle, or glass of soda or pop, such as Coke, Pepsi, or Sprite?*

Never ate breakfast

Answered '0 days' to the question, *During the past 7 days, on how many days did you eat breakfast?*

Physical Activity

Watched TV three or more hours per day

Answered '3 hours per day' or more to the question, On an average school day, how many hours do you watch TV?

Computer use or video gaming three or more hours per day

Answered '3 hours per day' or more to the question, *On an average school day, how* many hours do you play video or computer games or use a computer for something that is not school work? (Include activities such as Xbox, PlayStation, Nintendo DS, iPod touch, Facebook, and the Internet.)?

Screen time three or more hours per day

Answered a combined total of '3 hours per day' or more to the two questions above No PE in school

Answered '0 days' or more to the question, *In an average week when you are in school, on how many days do you go to physical education (PE) classes?*

Other Topics

Ever had an HIV test

Answered 'Yes' to the question, *Have you ever been tested for HIV, the virus that causes AIDS? (Do not count tests done if you donated blood.)*

Dental visit in the last 12 months

Answered 'During the past 12 months' to the question, *When was the last time you saw a dentist for a check-up, exam, teeth cleaning, or other dental work?*

Diagnosed with asthma

Answered 'Yes' to the question, Has a doctor or nurse ever told you that you have asthma?

Current asthma

Answered 'Yes' to the question, *Has a doctor or nurse ever told you that you have asthma?* AND Answered 'Yes' the question, *Do you still have asthma?*

Gambling

Answered '1 or 2 times' or more to the question, *During the past 12 months, how many times have you gambled on a sports team, gambled when playing cards or a dice game, played one of North Carolina's lottery games, gambled on the Internet, or bet on a game of personal skill such as pool or a video game?*

Physical disability

Answered 'Yes' the question, *Do you have any physical disabilities or long-term health problems? (Long-term means 6-months or more)*

Unstable housing

Gave any response other than 'At home with my parents or guardians' to the question, *Where do you typically sleep at night?*

Speaks a non-English language at home

Answered 'More than half the time but not all of the time' OR 'All of the time' to the question, *How often do you speak a language other than English?*

Born in the USA

Answered 'Yes' to the question, Were you born in the USA?

Appendix B: Script for Teachers Administering Survey Script for teachers to read to students:

Good morning/ afternoon, students.

Today you are going to complete a set of questions about your general health and well-being. This is called the Youth Risk and Resilience Survey. The survey is completely anonymous—there will be no way that anyone can tell what your answers are. All the answers will be put together to help CCS understand our student body's health situation, strengths, and challenges.

This survey will take about one class period. Do your own work and keep your eyes on your own computer. When you're finished, you may work on assignments for any of your classes or read a book.

It's possible that your feelings may be affected by some of the questions. If any of the questions make you feel that you need help, or someone to talk to, you have a sheet in front of you with the names of people who can help you and how to contact them.
